

Reserve Bank Health Society Induction Promotion Terms and Conditions 2026

RESERVE BANK HEALTH SOCIETY (RBHS)

Eligible new joiners who meet RBHS eligibility criteria will receive a \$200 VISA gift card and go into the major prize draw to win a \$500 VISA gift card.

1. 3. **Eligibility criteria:** Entry is only open to persons over the age of 18 years and is a current or former employee of the Reserve Bank of Australia (RBA) and Note Printing Australia (NPA). The following persons are ineligible to enter the Promotion:

4. **Promotion Period:** This Promotion will be open from 6:00am AEDT **23rd February** 2026 to 11:59PM AEDT on **23rd March** 2026 (**Promotion Period**).
